### **INTRODUCTION**

The roles and responsibilities of the FIDE Trainer's Commission (TRG) are detailed in the FIDE Handbook at [chapter A02](#) and [chapter B07](#) and at our website: [trainers.fide.com](https://trainers.fide.com)

### **ORGANISER(S)**

The FIDE Trainer's Commission (TRG) seeks to organise FIDE Trainer Online Seminars in all major and regional languages.

TRG, where possible, directly or through pre-qualified FIDE Academies (Regional), will work with FIDE Affiliated Organisations and fellow FIDE Commissions for the promotion and conduct of FIDE Trainer Online Seminars.

Where TRG has appointed a co-organiser, usually a FIDE Academy, the registration of participants and the collection of fees will be the co-organiser's responsibility.

TRG will ensure the quality and integrity of the seminar and the award of titles and licences by approving the lecturers and topics at the lecturer, monitor the seminar in real time and through recordings, and provide independent examiner(s)

## **PARTICIPATION IN A SEMINAR**

Information about a FIDE Trainer Online Seminar will be published on the TRG Website [trainers.fide.com](https://trainers.fide.com) as it become available.

Everyone who plays chess can attend a FIDE Trainer Online Seminar but may only take the examination to qualify for a FIDE Trainer Licence if they have a FIDE ID and which is issued by their respective Federations.

The fee for a FIDE Trainer Online Seminar is fixed at Euro 200 and is paid before the start of the seminar.

By your participation in the seminar, you have agreed to comply with the approved rules and regulations.

## **THE CONDUCT OF THE SEMINAR**

FIDE Trainer Online Seminars must be conducted either over a minimum three (3) days and no longer than two weeks, with 16 hours of lectures and/or panel discussions.

The topics and lecturers as well as panellists for a FIDE Trainer Online Seminar can be proposed by the co-organiser and are approved by the TRG Exam Panel/Board.

Zoom is the official platform for FIDE Trainer Online Seminars.

Each seminar will have a facilitator/moderator who will assist both the lecturers and participants with using Zoom pre-seminar, organise access to and will start and end each lecturer, while assisting in any user challenges during the seminar.

## EVALUATION FOR LICENCE AWARD

The evaluation for the title and licence award is based on, and made in five areas as follows:

1. FIDE Rating **or Equivalent** (20%)
2. **Overall** Student Results (30%)
3. Experience / **Special Achievements** (20%)
4. **Trainer & Related** Professional Skills (10%)
5. Written Exam (20%)

Participants are required to complete a Questionnaire where the information provided will be verified and used for the evaluation.

A written exam based on the topics taught at the seminar will be emailed independently by the examiner to the participants qualified to be examined and which needs to be returned within a designated time frame.

The results will be reviewed by the TRG Exam Panel/Board before endorsement by the TRG Council and then submitted the FIDE Council (which usually meets quarterly) for approval.

Appeals may be allowed in special circumstances where the decisions of the TRG Exam Panel/Board are final.

Currently four titles are examined at seminars:

1. **Developmental Instructor**
2. **National Instructor**
3. **FIDE Instructor**
4. **FIDE Trainer**

The award of the FIDE Senior Trainer title is based on unanimous agreement by the TRG Council of the merits of a direct application which is then subject to approval by the FIDE Council.
